What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

THE CHICAGO BOARD OPTIONS EXCHANGE INVESTIGATED ALLEGATIONS MADE IN A CUSTOMER COMPLAINT (BY THIRD PARTY) AGAINST EGAN. THE COMPLAINT ALLEGED THAT EGAN FAILED TO SELL CERTAIN OPTIONS IN THE CUSTOMER'S ACCOUNT AS HE HAD BEEN INSTRUCTED. THE EXCHANGE'S INVESTIGATION DID NOT REVEAL REASONABLE GROUNDS FOR BELIEVING THAT A VIOLATION OF EXCHANGE RULES HAD BEEN COMMITTED. THE EXCHANGE THEREFORE TOOK NO ACTION. ACTION ENTITLED CUSTOMER VS. OPPENHEIMER GOVERNMENT SECURITIES, INC., OPPENHEIMER & CO., INC. AND STEVEN EGAN, FILED IN THE U.S.D.C. FOR THE NORTHERN DISTRICT OF ILLINOIS, EASTERN DIVISION. THE PLAINTIFF ALLEGED MISREPRESENTATION AND UNSUITABILITY IN CONNECTION WITH THE PURCHASE OF GNMAS. BY REASON OF THE FRAUDULENT AND TORTIOUS MISREPRESENTATIONS MADE BY THE DEFENDANTS TO PLAINTIFF, CUSTOMER PRAYS FOR JUDGMENT AGAINST OPPENHEIMER GOVERNMENT, OPPENHEIMER AND EGAN IN THE SUM OF \$54,687.50 PLUS COSTS, ATTORNEY'S FEES AND INTEREST. OPPENHEIMER DENIED LIABILITY BUT, IN THE INTEREST OF AVOIDING THE TIME AND EXPENSE OF PROTRACTED LITIGATION, THE MATTER WAS SETTLED FOR \$17,500.
