IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement The client has been the beneficiary of a discounted commissions on his



transactions for over the past 14 years. He and the previous financial advisor agreed to this arrangement prior to my taken over the account. Once that broker ceased to service his account, this arrangement ended and the client never approached me with a proposal to continue the discounts commissions or even inform me of the past arrangement. As this was never an agreement that was made with me, I processed all the trades within the normal price range of a commissioned based account. The client decided that he was entitled to his discounted commissions despite the fact that I knew nothing about it and thus requested restitution from the firm. The firm has denied his allegations as meritless and the matter has been closed.
