IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

CUSTOMER DISMISSED MR. RAAB FROM ARBITRATION WITH PREJUDICE. THEREAFTER, PAINWEBBER AGREED TO PAY CUSTOMER \$14,999 IN EXCHANGE FOR HER PARTNERSHIP INTEREST AND A FULL RELEASE OF CLAIMS. PAINWEBBER AND RAAB DENY ANY AND ALL LIABILITY AS ALLEGED. APPROXIMATE NET SETTLEMENT IS \$12,799. MR. RAAB WILL NOT BE ASKED TO CONTRIBUTE TO THE AWARD. I VEHEMENTLY DENY THAT I DID ANYTHING WRONG, ALTHOUGH I UNDERSTAND THAT PAINWEBBER DECIDED TO SETTLE AS A BUSINESS JUDGEMENT. I STILL CONTEND THAT THIS CLIENT WANTED TO PURCHASE THE EQUITY PARTNERS LP AFTER BEING INFORMED OF IT BY HER SON WHO MAINTAINED AN ACCOUNT AT PAINWEBBER IN BOSTON. PRIOR TO PURCHASE HE REVIEWED THE PROSPECTUS WITH THE CLIENT IN GREAT DETAIL, AND THEY DECIDED THE PURCHASE WAS A SUITABLE ADDITION TO A DIVERSE PORTFOLIO OF SECURITES. [FAMILY MEMBER] (SON) MAINTAINED A PAINWEBBER ACCOUNT AT THE TIME.
