FINRA MADE A DETERMINATION NOT TO TAKE ACTION AGAINST UBS, A FINRA MEMBER, OR THE MEMBER ASSOCIATED PERSON, ALAN WEBSTER, BASED ON THEIR ASSESSMENT THAT NO MISCONDUCT HAD OCCURRED, THEY CLOSED THEIR INVESTIGATION OF THE MATTER ON OCTOBER 18, 2010. ALTHOUGH IT WAS CLEAR THAT THERE WAS NO WRONG-DOING BY MYSELF, I UNDERSTAND THAT UBS SETTLED WITH THIS CLIENT FOR A NOMINAL AMOUNT TO AVOID THE UNCERTAINTIES OF THE COST OF THE ARBITRATION PROCESS. I WAS NOT ASKED TO CONTRIBUTE PERSONALLY ANY MONIES TOWARD THE SETTLEMENT OF THIS ISSUE.
