What is included in a IAPD report?

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

I DENY ALL ALLEGATIONS DIRECTED AT ME BY THIS CLIENT. I HAD BEEN DOING BUSINESS WITH THIS CLIENT FOR 25 YEARS IN A SUCCESSFUL MANNER FOR HER. SINCE COMING TO OPPENHEIMER SHE HAS WITHDRAWN MORE MONEY FROM HER RETIREMENT ACCOUNT (\$582,000) THAN SHE EVER PUT IN (\$574,000, INCLUDING LOAN REPAYMENTS) AND THERE IS \$76,000 LEFT AT PRESENT. I HAVE TALKED WITH THE CLIENT AT LEAST TWICE A MONTH OVER THE PAST THREE YEARS SINCE THE POSITION IN A WORLD WIDE INDUSTRY LEADING CORPORATION WAS INITIATED, LONG BEFORE AND AFTER THE OIL MARKETS TOOK A TURN FOR THE WORSE IN AUGUST OF 2014. SHE NEVER REITERATED THAT SHE THOUGHT SHE DESERVED TO RECEIVE COMPENSATION FOR THE POSITION IN QUESTION BUT THAT SHE WAS WILLING TO 'WAIT IT OUT' FOR BETTER TIMES. SHE REFUSED ADVICE TO ADD OTHER POSITIONS TO THE ACCOUNT OR AVERAGE DOWN IN THE POSITION IN QUESTION.
