What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

I HAD RECOMMENDED THAT CLIENT WITHDRAW \$200,000 FROM HIS PACIFIC LIFE TAX DEFERRED ANNUITY TO DIVERSIFY AND REINVEST INTO SOME TAX FREE INVESTMENTS. HE HAD A VERY LARGE PORTION OF HIS ASSETS INVESTED IN TAX DEFERRED INVESTMENTS. SINCE HE HAD SUCH A LARGE PORTION, THIS COULD CREATE ADDITIONAL TAXES IN THE FUTURE. HE HAD AN ORIGINAL INVESTMENT OF \$215,000, SO I WAS THINKING ABOUT THE OLD WITHDRAWAL RULE OF FIRST IN/FIRST OUT AND TOLD HIM THAT BECAUSE OF THAT HE SHOULD HAVE NO TAXES AS LONG AS WE DIDN'T WITHDRAW MORE THAN \$215,000. WE MADE THE WITHDRAWAL IN NOVEMBER 2010. THEN IN MARCH CLIENT RECEIVED A 1099 FOR OVER \$130,00 OF TAXABLE INCOME. WHEN HE CALLED ME TO QUESTION IT I TOLD HIM THAT IT COULDN'T BE CORRECT AND I WOULD CHECK AND GET BACK TO HIM. AS SOON AS I STARTED TO REVIEW EVERYTHING, I REALIZED THE MISTAKE I HAD MADE. I CALLED CLIENT BACK AND TOLD HIM ABOUT THE MISTAKE. I AGREED TO PAY THE ADDITIONAL TAXES THAT WERE DUE.
