**Broker Statement** The customer alleged that they were not aware of the risk factors of the investments they made. In reality the customer signed multiple forms attesting to the fact that they were aware of all risk factors of the investments transacted. In addition, during communications with the customer it became apparent their accounting in regards to the performance of the investments was not completely accurate. The customer was reminded of the risk disclosures they had signed and the firm assisted the customer to better understand the performance of the investments to that point. As there has been no further communication with the customer the complaint has been closed.
